Dear Food Vendor Applicant,

Thank you for your interest in providing food vending services at the Crescent Bar Recreation Area. There are three (3) food vendor spaces with 50 amp/220-volt power, wastewater hook up, and shared water.

Please complete the attached application form and submit a detailed business plan that includes a description of the service(s) you are proposing. The plan should include, but not be limited to:

- Description of company and services including your equipment and how much space is needed for your operation
- 2022 menu options with pricing and methods of payment accepted
- Marketing plan including website, proposed signs, etc.
- Description of operating hours and days, including holidays and closures
- Statement that a Certificate of Insurance will be provided for Grant PUD's required level of insurance
- List of licenses required to provide services (Business, Health Department, etc.)
- Resume(s) of key staff that will operate the food truck on Grant PUD property
- Number of employees
- References: List of names, addresses, phone numbers, and email addresses of two (2) references which have used your services
- Other information that will help us fully understand your proposal

Options for rates:

- Daily: \$25
- Weekly: \$75
- Monthly: \$200
- Season (May 1, 2022 to September 30, 2022): \$500
- All vendors will be charged 12.84% leasehold tax on the total rent

Grant PUD reserves the right to request any additional information it deems necessary for the review process. The PUD shall be the sole judge of the merits of the proposals received. Rent is due at the time of a fully executed agreement.

The application fee is \$75.00 (paid once per season). Do not include \$75.00 application fee; fee will be billed after initial review. Please mail or email the application package to:

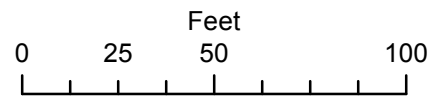
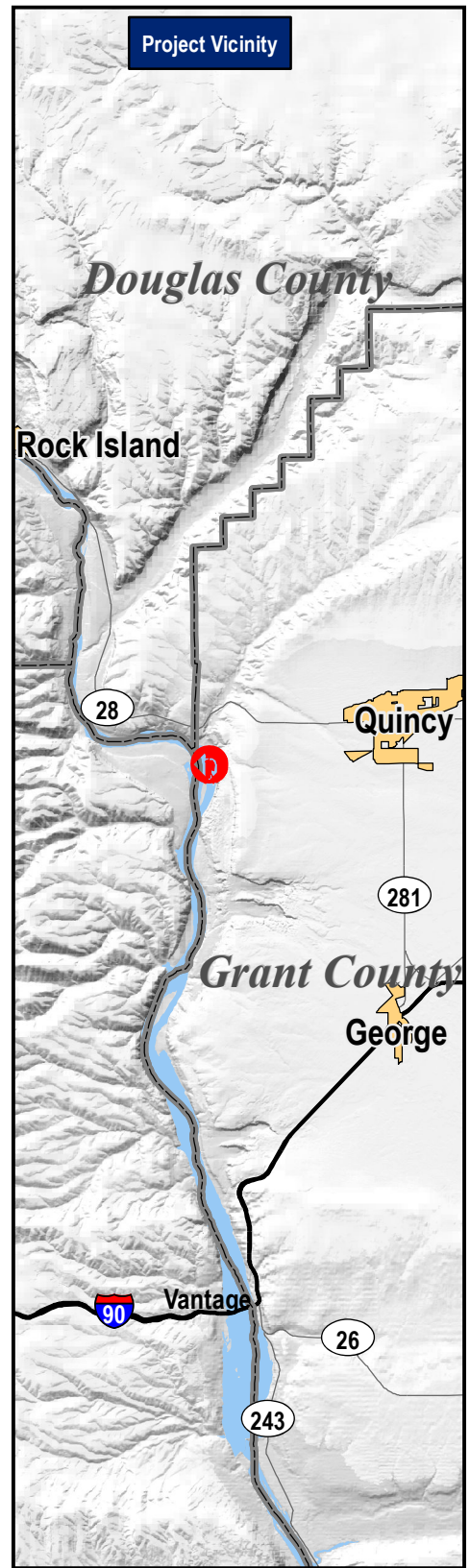
