### Decisions and Approvals Made During June 28, 2022, Meeting

# **Agenda**

- I. Welcome, Announcements and Introductions Bryan Nordlund welcomed everyone and shared that Jim Craig and Kirk Truscott could not attend the PRCC meeting today.
- II. Agenda Review Bryan Nordlund asked committee members to provide him their Policy committee members contacts information (phone number and email addresses, minimally). He needs this information to help set up a Policy committee meeting tentatively scheduled sometime in September 2022.

# IV. Status of Actions Items from May 24, 2022, Meeting

- A. Nordlund has followed up with John Ferguson and Douglas PUD to discuss options for future Coordinating Committee meetings. Tentatively, meetings will be held at two locations (Douglas PUD auditorium and Wanapum HOB-107) with virtual access available, and virtual only meetings (poor weather months).
- B. Follow-up on Corp/BOR Avian Predation Management (Skiles, Carlon and Dotson work in progress).

# V. 2021 Fish Passage Operations Report

## A. Update on investigations for fish count discrepancy:

Updates from Curt and PRCC discussion. - Curt Dotson discussed that the third-party contractor review and testing are ongoing at the Wanapum/Priest Rapids fish count stations. They have found some technical issues with the fish count video monitors and this is being corrected. Curt shared that better awareness has been gained with fish counters reviewing and double checking before they post their counts. Tom Dresser shared he's spoken with craft journeyman, and they reported that they are not seeing fish when they open the crowders. Tom shared that Grant employs seven on-call Fish Counters. Improvements to deal with issues leading to count inconsistencies have been identified. Fish Counter training has helped, and improvements have been confirmed. Bryan Nordlund asked if Chelan PUD's fish counting equipment and processes are different than Grant PUD's. Tom Dresser confirmed that they are different. For example, Chelan PUD counts mini jacks and Grant does not count the mini jacks. Committee members discussed that this is a high-water level year and fish counts are high this year.

# B. Fish ladder inspections:

Tom Skiles performs monthly ladder inspections at the GPUD dams for the fisheries agencies and tribes. Tom skills shared last month he was in person for his inspections and differentials were within safe margins. The month of June he did his inspection virtually, with great inspection results.

# C. Fish spill updates:

Spill season has commenced for the juvenile outmigration (April 2022).

Keely Murdoch reported to committee members that she made and sent edits to Bryan Nordlund on the strawman document he created. She shared that she borrowed some verbiage from the settlement agreement, not identical and only on the tasks that she feels works for this committee. Keely discussed the edit's she made to Bryan's strawman. One example is asking for next meeting's agenda items at the end of each PRCC meeting. Committee members agreed that the timing has been good on draft meeting minutes stating they are sent out with plenty of time to review. Curt Dotson and committee members agreed that going forward NNI Survival Study plan will have a 45-day review period at the release date and 30 days to report and comment for final approval. Tom Dresser asked Bryan Nordlund to look at the settlement agreement language 5.4 for correct process on absentee votes.

Action: Bryan Nordlund to send committee members Keely Murdoch's edits and review settlement agreement for committee actions.

### VII. Discussion - Future meeting locations and times.

Currently, PRCC meeting location options include Douglas PUD auditorium, Wanapum HOB-107 and virtual meetings. We decided last meeting to use all of

these locations in a yet to be determined order. The request made was that the "home team" committee (eg. GPUD is the "home team" at Wanapum) meetings take place in the afternoon, with the "visitors" meetings take place in the morning. An example of this is happening today. Committee members reviewed the meetings schedule and developed a plan for the remainder of 2022. **Action: Bryan Nordlund will send out the updated spreadsheet to committee members.** 

# VIII. Discussion - Survival study preliminary discussions.

Focus on fleshing out list from last meeting and prioritize discussions. Potential discussion points include:

- timing, species, life stage(s)
- future workshops needed?
- tag type
- standard to measure (combine projects? combine adult + juvenile?)
- accuracy/precision of data analysis
- fish source
- release points
- assessing tag and tagger effects detection points
- dealing with adverse river flow conditions
- plant operations
- achieving standard or not path forward
- factoring in avian predation
- others, per PRCC discussion?

Bryan Nordlund asked committee members to select 3-4 priorities from the bullet points that they want to better understand before future studies. Committee members discussed future Grant PUD survival studies and fish studies that are currently taking place. Keely Murdoch shared that SOA 2018-01 shows when the future Grant PUD survival studies will take place. This is the SOA that approved revised study dates to make better sense going forward. Keely shared that Chelan PUD did a study last year with "injectable" tags. She said they released groups at Rock Island/Rocky Reach forebay and tailrace and that this gives her hope to study sub-yearling summer Chinook, allowing the independent measure of survival of adult and juvenile fish. Tom Dresser asked that Bryan Nordlund stick with Summer Chinook only when discussing settlement issues, and not include fall Chinook since they are designated separately in the settlement agreement. ACTION: Curt Dotson will add two to three sentences that describes what each bullet point is referring to and share why Grant has selected this in the past. He will include plan operations, standards, and future workshops. And Bryan Nordlund to send SOA 2018-01 and 2019-01 to committee members.

# IX. Review of Outstanding NNI Funded Projects

- A. Lower Wenatchee Instream Flow Enhancement Project Phase II (no updates)
- B. Avian Predation on ESA-listed Juvenile Salmonids on the Mid-Columbia River, 2021 (weekly updates have been forwarded to PRCC) Bryan Nordlund shared he emails the reports out. Curt Dotson shared on 4/8/2022 they tagged steelhead and 5,543 steelhead smolts, for a total of 6,083 PIT-tagged steelhead that may be detectable for avian predation studies this year. Tom Skiles added that RTR included 550 previously PIT-tagged fish as part of the 6,083 total.
- C. Barkley Irrigation Company Permanent Point of Diversion Completing Implementation of the Permanent Solution (no updates) Bryan Nordlund will call for an update this summer.
- D. Northern Pike Removal (2022-2024) in place Tom Dresser shared that the Colville Nation is leading a committee charged with developing and implementing a rapid response plan for Northern Pike detections from Grand Coulee Dam to Wanapum Dam. The Grant, Chelan and Douglas PUD's are involved with this committee with the Colville's to develop a coordination and communication plan for instances when a Northern Pike is found. Tom Dresser also shared a carcass that was found in 2021 in the John Day pool was sent out to verify if it's a tiger muskie.
- E. Quincy Pikeminnow Derby Completed, update was provided at the May meeting. This can be removed from agenda.
- F. Wenatchee PIT tag barge exception to SOA 2013-04 granted and in place. The barge is in the river at the north end of Wenatchee. Tom Skiles asked for efficiencies updates. Chad Jackson shared that he will send them out to committee members when he receives them.
