Dear Marina Vendor Applicant,

Thank you for your interest in providing Marina Vendor services at Crescent Bar Recreation Area. There are ten (10) commercial slips available. Please complete the attached application form and submit a detailed business plan that includes a description for the service(s) you are proposing. The plan should include, but not be limited to:

- Marketing plan including proposed signs, banners, etc., and location on Grant PUD property
- Fees/prices and methods of payment accepted
- Number of employees
- Number of marina slips requesting and for how long
- Boat registration #s, make and model of watercraft
- Description of operating hours and days, including holidays and closures
- Statement that the appropriate insurance will be obtained
- List of permits needed for your service (Health Department, etc.)
- Description of your equipment and how much space is needed for your operation
- Other information that will help us fully understand your proposal

Please return your application, appropriate fees, and business plan by **April 2, 2021 at 3 pm.**

The application fee is \$75.00.

Two options for seasonal rates:

- Regular Season: May 15, 2021 to September 15, 2021, marina slip rent will be \$1,500.00 per slip
- Extended Season: May 1, 2021 to September 30, 2021, marina slip rent will be \$1,750.00 per slip
- All vendors will be charged a 12.84% leasehold tax on the total amount

An application must be approved to provide commercial services within Grant PUD property. Rent is due at the time of permit approval. Grant PUD reserves the right to request any additional information that it deems necessary for the review and award process. The District shall be the sole judge of the merits of the proposals received.

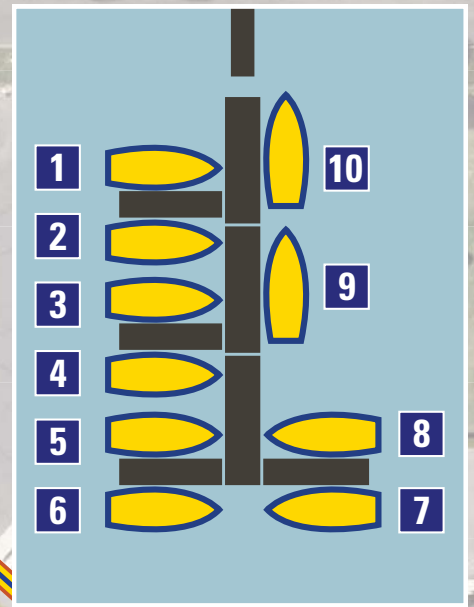
